## INTRASTAT: Intra-Community Trade Statistics (ICTS)

For the statistical survey of the mutual trade between EEC countries, all companies within the European Community are obliged to report statistical data to their responsible national authorities. For this purpose, a so-called Intrastat declaration is transmitted electronically to the Federal Statistical Office in Germany.

### Use functions

Our Intrastat Partner Notification software solution allows you to take on the Intrastat Notification for your foreign branch or business partner within the EEC. The reports for the statistical authority of the EEC country of destination or exporting country are generated directly from our system, while complying with the various country-specific standards and reporting formats. In addition to the associated rationalisation benefits, you gain the possibility of a statistical evaluation of your goods movements.

We offer you a comprehensive solution with which double-sided reporting (e.g. inter-company deliveries) is also possible. In this case, the data record can be used to create both the dispatch report and the arrival report for the EEC goods recipient, e.g. for deliveries to EEC subsidiaries.

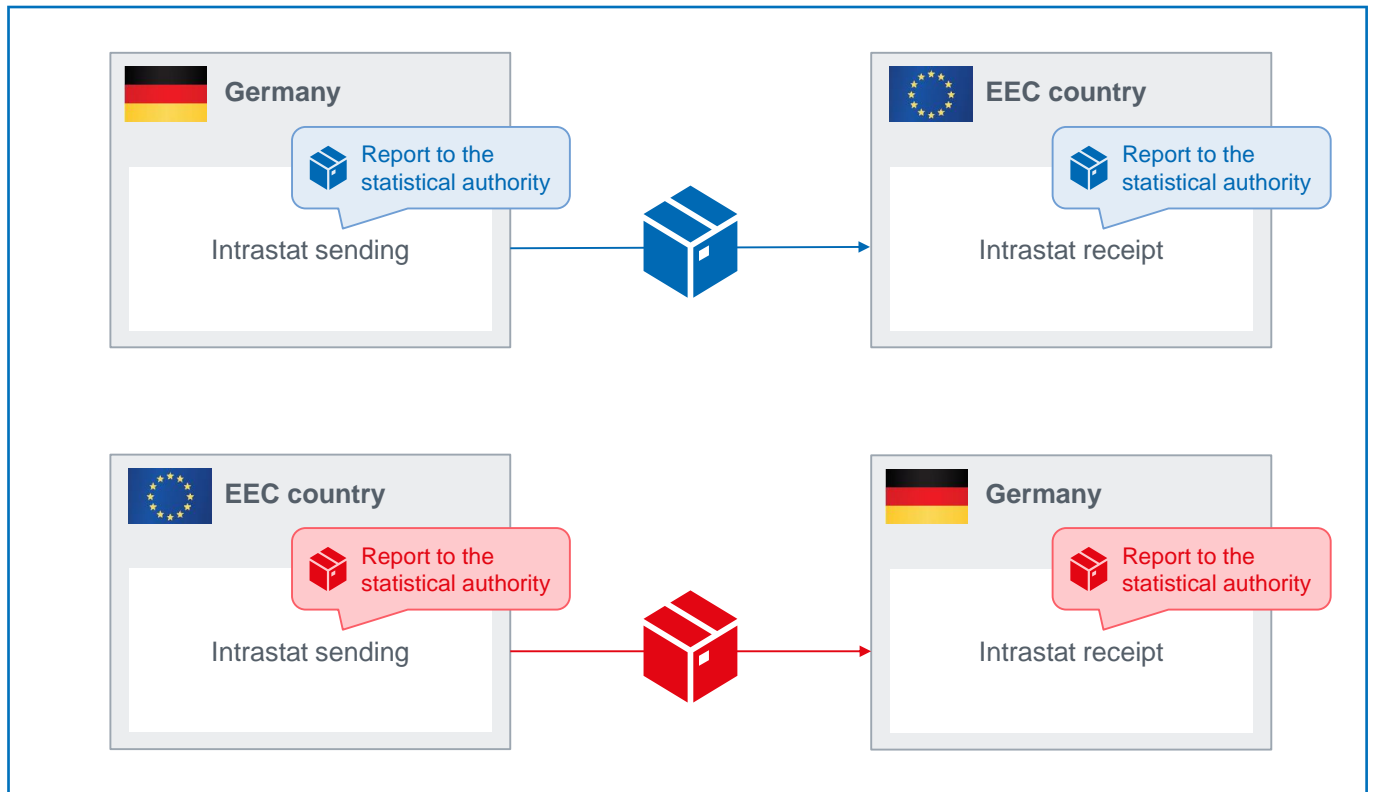
### Secure advantages
