Design your processes clearly by assigning the various tasks to the right people directly in the software.

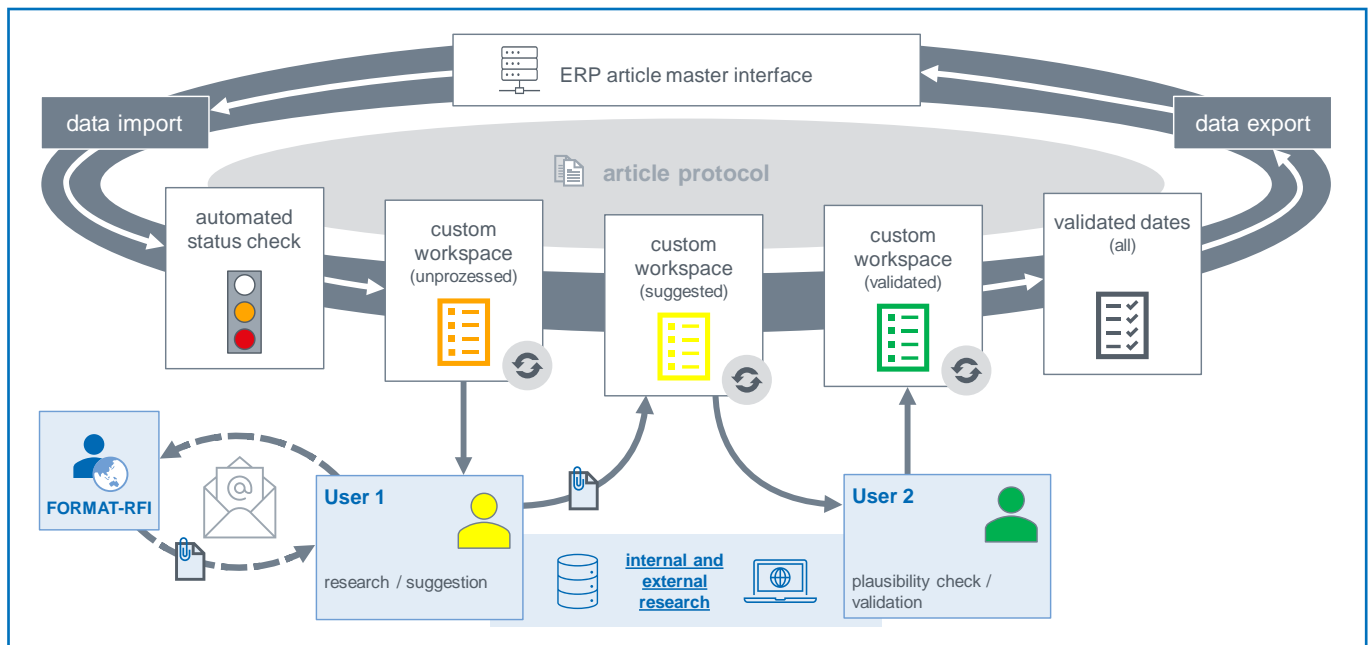
