## FORMAT-WUP: Goods origin and preference calculation

External requirements are becoming greater and greater: The number of preferential agreements is continuously rising. This creates a high level of complexity due to content deviations in the agreements. Companies are also unsettled by the legal consequences of non-compliance. There is a considerable risk of being unable to present the relevant preference documents. Companies that can disclose preferences have all the more opportunities in international competition.

### Use the functions

The software allows you to request, manage and issue long-term supplier declarations. You can also manage your itemised documents (individual supplier declarations, EUR.1, EUR.MED, declarations of origin).

Thanks to the difference request, you no longer have missing or double-requested LTSDs. In addition, plausibility checks during posting ensure a lower error rate. Monitor and follow up on requested supplier declarations via three dunning levels. Determine theoretically possible agreements based on itemised document data. Based on sales data, possible articles are suggested for issuance. Created supplier declarations always comply with the current specifications of the Union Customs Code.

Use the preference calculation based on the parts lists in FORMAT-WUP or the preference determination of individual parts lists (sales orders and production/manufacturing orders).

Different calculation intervals or a calculation for a specific target date are possible. Benefit from the reminder or automated calculation of costings that are soon to expire. Diagonal cumulation and general tolerances are applicable. Minimum handling and sets of goods according to AV3. Get a detailed calculation result with the overview of the checked goods receipts and preference documents.

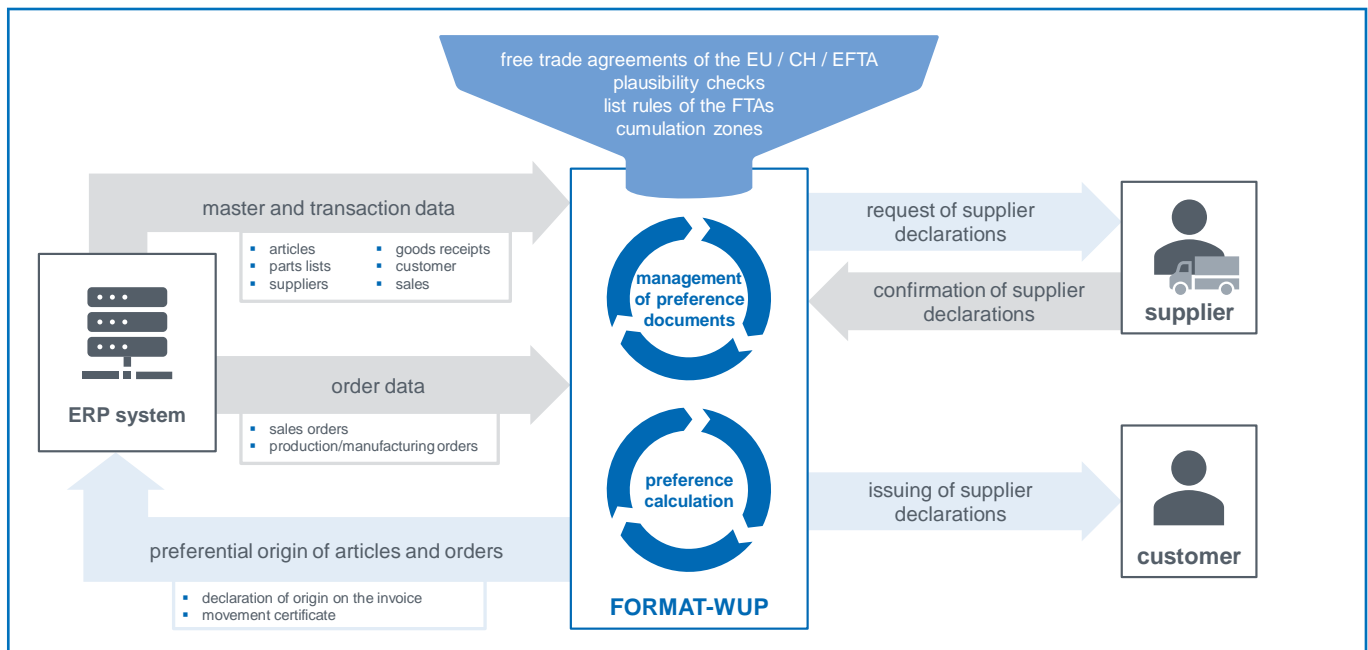
